national, regional and international levels. It was agreed that a five year review of Earth Summit progress would be made in 1997 by the United Nations General Assembly meeting in special session.

The full implementation of Agenda 21, the Program for Further Implementation of Agenda 21 and the Commitments to the Rio principles, were strongly reaffirmed at the World Summit on Sustainable Development (WSSD) held in Johannesburg, South Africa from 26 August to 4 September 2002.

What gives Agenda 21 Ruling Authority?

More than 178 nations adopted Agenda 21 as official policy during a signing ceremony at the Earth Summit. US president George H.W. Bush signed the document for the US. In signing, each nation pledge to adopt the goals of Agenda 21.

In 1995, President Bill Clinton, in compliance with Agenda 21, signed **Executive Order #12858** to create the President's Council on Sustainable Development in order to "harmonize" US environmental policy with UN directives as outlined in Agenda 21. The Executive Order directed all agencies of the Federal Government to work with state and local community governments in a joint effort "reinvent" government using the guidelines outlined in Agenda 21.

Who is Sneaking Agenda 21 into the United States?

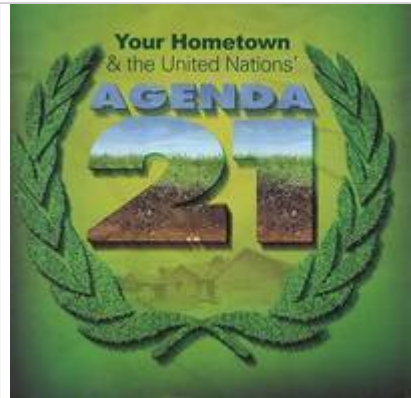

Ask Your State Legislators to Introduce a Stop Agenda 21 Bill

So far, the following actions have taken place:

On April 24, 2012, the Tennessee Senate also passed **HJR 587** by a vote of 19-11. This makes Tennessee the first state where both legislative houses have passed anti-Agenda 21 legislation.

April 25, 2012: The Tennessee House passed by 72-23 **HJR 587**, which is a non-binding resolution that “recognizes the destructive and insidious nature of United Nations Agenda 21 and hereby exposes to the public and public policymakers the dangerous intent of the plan... [and] BE IT FURTHER RESOLVED, that the federal government and state and local governments across the country be well informed of the underlying harmful implications of implementation of United Nations Agenda 21 destructive strategies for ‘sustainable development,’ and we hereby endorse rejection of its radical policies and rejection of any grant monies attached to it.”

May 10, 2012: The Arizona Senate passed **SB1507** by 21-9 on March 1, 2012. This wide-ranging bill states: “The state of Arizona and all political subdivisions of this state shall not adopt or implement the creed, doctrine, principles or any tenet of the United Nations Rio Declaration on Environment and Development and the Statement of Principles for Sustainable Development adopted at the United Nations Conference on Environment and Development held in Rio de Janeiro, Brazil in June, 1992 or any other international law that contravenes the United States Constitution or the Constitution of Arizona.” This bill died in the Arizona House when the legislature adjourned May 3, 2012.

The list of states which have introduced anti-Agenda 21 bills in 2012 now includes: Alabama, Arizona, Georgia, Kansas, Louisiana, Minnesota, New Hampshire, and Tennessee.

May 16, 2012: The Kansas House adopted an **anti-Agenda 21 resolution** by 76-41 on May 10, 2012. This non-binding statement does not need Senate approval, and is now sent to all members of the Kansas congressional delegation.

June 4, 2012: The Alabama Legislature has passed (and the Governor

signed) an excellent, binding anti-Agenda 21 bill, [SB477](#), that is worthy of emulation by the rest of the states in 2013.

May 30, 2014: The "Oklahoma Community Protection Act" ([HB2807](#)), which would prohibit adoption of policies that restrict private property rights without due process, among other things, was passed by the Oklahoma House by a vote of 66-26 on March 4. On March 25, this bill was reported out of the Senate Committee on the Judiciary with the recommendation "Do Pass." Unfortunately, this bill failed to pass in the Senate before adjournment on May 30, 2014.
